Please note the following:

The personal data that you enter on your membership form (or have given us on membership forms in previous years) will be used only for the Society’s membership administration.

It will be entered in to a database on a personal computer owned and used by the Membership Secretary, to which no-one else has access. The database may be shared with other Officers and Committee Members of the Society, but will not be made available to any other individual or organisation for any purpose. Should you not renew your membership by September 1st 2019, your data will be deleted from the database.

The membership forms will be kept securely by the Membership Secretary, and will be made available to the auditor in March/April for the purpose of reconciling the membership records with membership income. Thereafter the membership forms will be destroyed by shredding or burning by September 1st 2019.

Our preferred method of communicating to you any news about the Society, including last minute changes to our programme of events, and information about other related cricketing matters, is by e-mail.
